IT IS HEREBY STIPULATED AND AGREED, by and between plaintiff's attorneys and defendant(s) and/or defendant's attorney as follows:

- 1. Defendant consents to the jurisdiction of this Court, waives all offsets and/or defenses, and discontinues all counterclaims with prejudice.
- 2. Defendant shall pay \$ 18,000.00, without any interest as full settlement of this action. The settlement shall be paid by consecutive monthly payments of \$ 100.00 due on or by the 25th day of every month commencing on the 25th day of February, 2016.
- 3. Payments are to be made by check or money order made payable to "Forster & Garbus, as attorneys", and sent to Forster & Garbus at P.O. Box 9030, Commack, NY 11725-9030.
- 4. Should any payment not be received by the due date, or should any check sent in payment be returned by the bank for any reason whatsoever, and the payment not be received within 10 days after written notification to defendant and/or defendant's attorney, plaintiff shall have the right to enter judgment without further notice, for the suit amount, less any payments received, together with costs and disbursements.
- 5. Upon full payment of the settlement sum, a stipulation of discontinuance shall be filed with the Court.
- 6. Whenever \$600.00 or more of a debt is forgiven as a result of settling a debt for less than the balance owing, the creditor may be required to report the amount of the debt forgiven to the Internal Revenue on a 1099C form, a copy of which would be mailed to you by the creditor. - 7. Defendant, his/her heirs, successors, legal representatives and assigns hereby release, acquit and forever discharge Plaintiff and all of its affiliates, parents and/or subsidiaries, including, without limitation, is representative managing partners, officers, directors, shareholders, employees, agents, assigns, successors, servants, insurers, and representatives (including attorneys) from any and all claims, liabilities, demands, suits, and causes of action of every nature and kind, whether vested or contingent, accrued or unaccrued, known or unknown, in law or in equity, matured or unmatured, whether or not such claims were or could have been raised herein, or a result of any activities related to the debt and/or Plaintiff's account
